The Know Your Worth Art Competition, sponsored by the Northern Marianas Coalition Against Domestic & Sexual Violence, is open to all current CNMI Middle School and High School students (grades 6-12). Students are welcome to submit their original two-dimensional artwork addressing themes related to teen dating violence and/or healthy relationships for young people. The aim of this contest is to create awareness during Teen Dating Violence Awareness Month in February. The deadline for submissions is 5:00 pm on Friday, February 2, 2024.

Middle School Division (6-8)

1st Place - \$150 2nd Place - \$100 3rd Place - \$75

High School Division (9-12)

1st Place - \$150 2nd Place - \$100 3rd Place - \$75

Rules and Guidelines

Two-dimensional artwork that will be accepted include paintings, drawings, collages, prints, mixed media, computer-generated art, and photographs. Each artwork can be no larger than 24 inches long and 24 inches wide. It also cannot weigh more than 5 pounds.

Artwork must be original in concept, design, and execution. Artwork must comply with U.S. and CNMI copyright laws, meaning it should not include any designs, images, or text that were not created by the student. Artwork is strictly prohibited from featuring designs, images, or text generated by Al. Artwork must also be appropriate for display in public spaces, such as public libraries and K-12 schools. Artwork that is not done entirely by the student, violates copyright laws, is not a medium listed above, is larger than the guidelines above, and/or is not appropriate for public display will not be accepted.

Students may submit only one artwork that addresses the theme(s) for this competition. Additional artwork, photos or scans of the artwork, artwork without a completed Student Information & Media Release form specific to this competition, and/or artwork that is submitted after the submission deadline will not be accepted.
