# **KNOW YOUR WORTH ART, ESSAY & SPOKEN WORD COMPETITION**



The Know Your Worth Essay Competition, sponsored by the Northern Marianas Coalition Against Domestic & Sexual Violence, is open to all current CNMI Middle School and High School students (grades 6-12). Students are invited to write about teen dating violence and/or healthy relationships for young people by addressing one of the writing prompts below in a 300 to 500 word essay. The aim of this contest is to create awareness during Teen Dating Violence Awareness Month in February. The deadline for submissions is 5:00pm on Friday, February 2, 2024.

## Middle School Division (6-8)

1st Place - \$150 2nd Place - \$100 3rd Place - \$75

## **High School Division (9-12)**

1st Place - \$150 2nd Place - \$100 3rd Place - \$75

### Rules and Guidelines

Students must select one writing prompt below to address in their essay:

- 1. Describe how you think culture affects the way CNMI youth view healthy relationships and dating violence.
- 2. How common do you think violence or abuse is in relationships in the CNMI? Describe what you think needs to be done to help youth and teens experiencing violence or abuse in a relationship.

State which prompt you will be addressing in your essay. Essays **must have** a minimum of 300 words and a maximum of 500 words not including student information, the writing prompt, and citations. Essays **must be** original work with all sources (if any) cited. Essays **must not** violate the privacy of others (that includes but is not limited the use of real names), **must not** plagiarize the work of others, and **must not** violate U.S. and CNMI copyright laws. Essays **must not** incorporate text that is Al generated. Essays that were not entirely written by the student, and violate privacy and copyright laws **will not** be accepted.

Students may submit only **one** essay for this competition. Additional essays, essays without a completed Student Information & Media Release form specific to this competition, essays that do not meet the word count guidelines, and/or essays submitted after the submission deadline **will not** be accepted.
